



Gujarat judiciary Prelims Exam Pattern 2022

The preliminary examination is also known as a screening exam. Only eligible candidates are invited to the preliminary examination. The test is administered to identify the most qualified applicants. The questions on the Preliminary examination are multiple-choice. Following is a list of papers that are conducted.

- Candidates have to attend both Papers I & Paper-II.
- In Paper I Questions will be from Law subjects. This paper will be conducted for 100 marks and time duration will be of 2 hours.
- Paper-II Consists of Questions from the subjects English, General Knowledge, and Awareness. Paper-II will be conducted for 100 marks in a time frame of 2 hours.

- In Paper II the 75 questions will be asked from the Civil subjects. You have to answer these questions for a duration of 150 minutes.
- Paper III will be conducted to test the candidate in the Gujarati language for 50 marks in a duration of 90 minutes.
